### 1. PARTICIPATION FEE & CANCELLATION

For any reason, the Organiser decide to cancel or postpone this exhibition, the Organiser will not be responsible for bearing all airfare, hotel or other travel costs incurred by the Exhibitors. ### 3. PROHIBITIONS
